SUBJECT: Impacts on South Parking Traffic Due to the Opening of the New Bus Loop

The purpose of this building circular is to inform all Pentagon building occupants about the changes to traffic patterns on the Reservation due to the opening of the Bus Loop portion of the Virginia Department of Transportation's 395 Express Lanes Project.

Beginning Thursday, May 23, 2019 the new Bus Loop around South Parking Lot Lanes 27 to 33 (the Pork Chop) will be open for all buses (shuttles buses, Metro Buses, Commuter Buses, etc.), and authorized vehicles traveling in and out of the Pentagon Transit Center (PTC) (See attachment). Please note the following changes to the traffic patterns in South Parking

- Bus Loop (Outer Roadway of the Pork Chop): Beginning Thursday, May 23, 2019 the Bus Loop will open for all shuttles, transit and commuter buses, and authorized vehicles accessing the PTC. The Eads Street access to the PTC will be closed.
 - The Eads Street and South Rotary Road intersection will become a two-way intersection with police officer direction during Monday through Friday rush hours and stop signs for other times.
 - All buses, shuttles, and authorized vehicles can access the Bus Loop from both Eads Street and South Rotary Road. Passenger vehicles are not permitted onto the Bus Loop. Four way flashing traffic lights and police direction will control traffic at the South Rotary and Eads Street intersection.
- Parking in Lanes 27-33: There is no change in parking. S-C permit holders and authorized contractors will continue to use the current entrance at Eads Street and North. Rotary Road to enter and exit the Pork Chop.
- **Slug Stations**: Normal slug operations will continue. Vehicles will continue to use the current entrance at Eads Street and North Rotary Road to enter and exit the Pork Chop. Pedestrians will use the newly constructed sidewalk and ramps to access the vehicles for pick-up. Slug shelters will be re-installed for pedestrians and signage will be in place.
- **Taxi Stand:** Beginning Thursday, May 23, 2019 the new Taxi Stand will be located within the Pork Chop Lot adjacent to Eads Street near the entrance of the Lot (See attachment).


