

# Attention Commuters

## Old Keene Mill Park and Ride Traffic Flow Options

### We Need Your Input!

The Old Keene Mill Park and Ride opened in December 2010 as a Fairfax County commuter facility offering 270 free parking spaces, bicycle and pedestrian amenities. However, the slugging community has operated on this site for over 35 years. Traffic flow in and around the lot sometimes makes driving difficult, and Lee District has asked for assistance in implementing improvements. Recognizing the long-standing slugging operations onsite, Fairfax County seeks the commuters' opinions about traffic in and around the parking lot.

Information is now online at [fairfaxconnector.com](http://fairfaxconnector.com) where commuters can view three different options for traffic flow through the parking lot. Commuters can comment on these options or provide other suggestions by emailing the Fairfax County Department of Transportation at [DOTInfo@fairfaxcounty.gov](mailto:DOTInfo@fairfaxcounty.gov).

When sending comments and suggestions, commuters are reminded to focus on **SAFETY**, **EFFICIENCY** and **CONVENIENCE**. Traffic flow must be:

- safe for pedestrians, vehicles, and others who travel in or near the lot
- efficient so commuters as well as regular daily traffic can proceed with minimal delays and interruptions
- convenient for riders as well as drivers so the slug operations may continue to thrive

The three proposed options include:

1. **Exit Only** (a suggestion we have received from several commuters already), where the parking lot entrance from Old Keene Mill Road becomes an Exit only, and vehicles must enter from Springfield Boulevard
2. **Two-Way**, where vehicles both enter from and exit to Old Keene Mill Road
3. **Entrance-Only**, where vehicles enter from Old Keene Mill Road, but have to exit via Springfield Boulevard

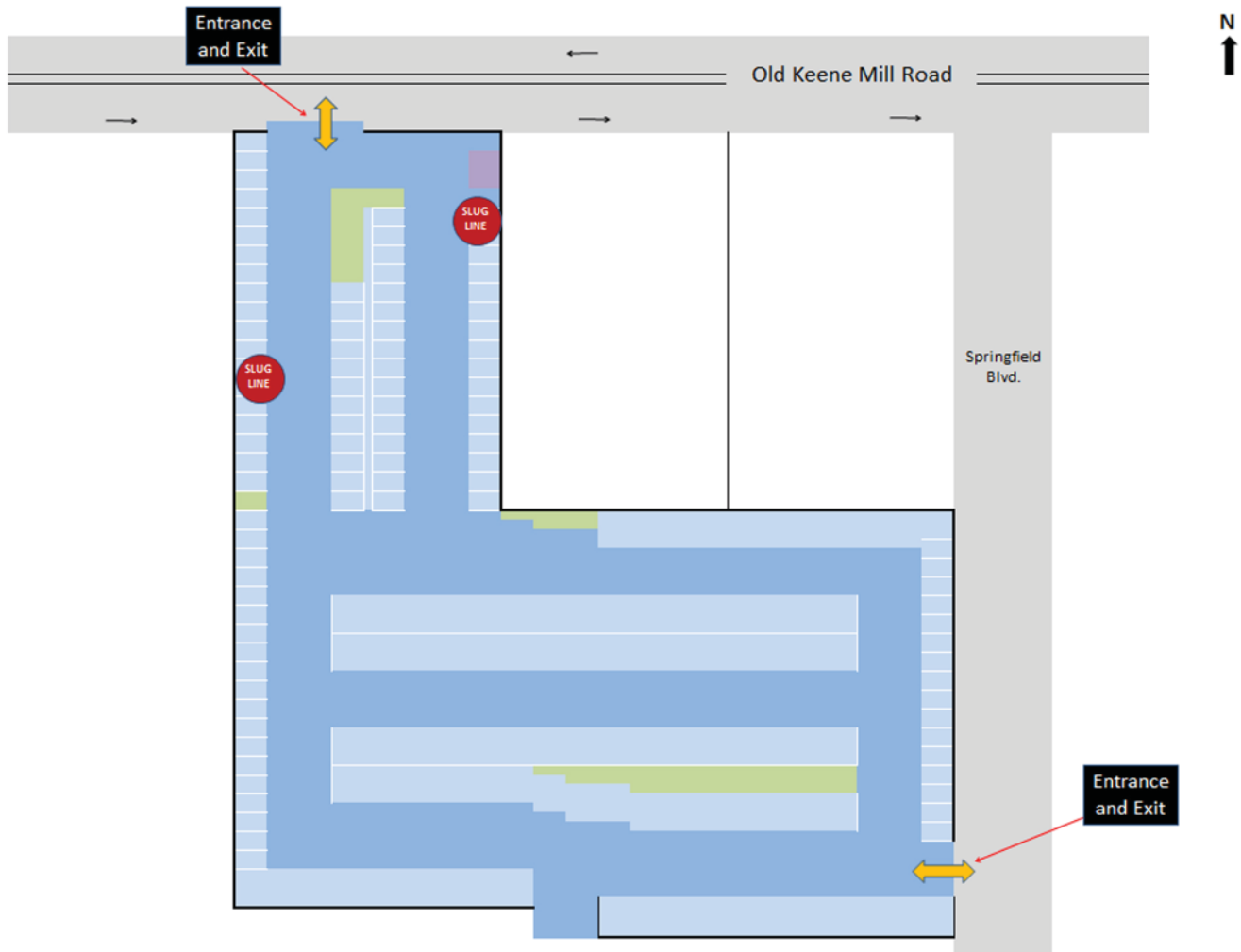
